**Subject: "Invitation to submit an offer for the transfer of the household goods in Brussels of the PSC Ambassador, due to her assignment to the Perm.Representation of Greece to NATO"**

The Permanent Representation of Greece to the EU, bearing in mind the provisions of Laws 4412/16 & 4782/21, as amended and in force, as well as the document with Ref.No 66820/10.12.2021 of the ST-B Directorate of the Ministry of Foreign Affairs, invites for the submission of an offer and the direct assignment, with the signing of a relevant contract, for the transfer of household goods (moving) to a new residence of the PSC Ambassador Mrs Vasiliki Gounari, budgeted expenditure up to twelve thousand four hundred Euros (€12,400.00), including VAT, according to the attached table of technical specifications, the faithful observance of which is a necessary condition for the selection of the final offer.

The offer to be evaluated should include:

- a) The individual and total costs, including charges and VAT, of the work provided and supply of necessary material.
- b) The duration of validity of the offer, with a minimum validity of one month.

The award criterion is the most economically advantageous offer.

Those interested should fill in and sign the attached table and then submit their offer either electronically (in PDF format, to the address adminfin@rp-grece.be), or by post or delivery in a sealed envelope to the secretariat of Administration-Organization department of the Permanent Representation (19-21 Rue Jacques De Lalaing 1040 Bruxelles), no later than **Tuesday, January 21 at 16:00 p.m.** Bids submitted late will not be considered.

Before the assignment, the contractor must provide:

- 1. tax and insurance awareness/information
- 2. Chamber of Commerce certificate
- 3. bank account details

The Permanent Representation reserves the right to request from the participants additional information necessary for the evaluation of the offers and the contractors are obliged to provide them. In addition, the Perm.Representation reserves the right to abort the procedure and to repeat it with or without modification of the terms. Participants have no financial claim in such case. Bids from economic operators who were not invited to submit a bid will not be considered. The award decision will be communicated electronically to the contracting entity.
