

The Embassy of Greece in Tehran Iran is to recruit three "field workers" for its Consular Department. It is going to be a temporary assignment, ending with no other prior notice on December 31st, 2017. Those to be employed will agree that, upon termination of their contract, are not entitled to compensation or pension by the Greek state. They may be recruited again, but no earlier than April 1st, 2018.

1) We are looking for people between 21st and 60 years old, with a college degree, fluent in Farsi and English, and with very good knowledge of computer systems (MS Word, MS Excel, Internet etc). Students in Universities or Colleges, with above mentioned qualifications, are also eligible.

2) The knowledge of the Greek language will be a significant asset.

3) The job description provides for people who:

-will assist the visa officers in issuing visas through the Schengen Visa Information System

--will promote to the Iranian public opinion and market Greek tourism destinations and packages of Greek tourist services

---will be skilled communicators of the Embassy`s policies regarding visas and how Iranian citizens shall apply.

---will work beyond working hours in cases of emergencies and exceptional working load, with due diligence, following the

instructions of the Head of Mission and safeguarding all classified procedures in the operation of the Embassy`s Consular Department.

4) A fixed monthly salary of 680 Euros is provided, but minor deductions (taxes and "social cohesion contributions") will apply, bringing the net amount to around 659 Euros. Social security coverage will be additionally paid by the Greek Embassy (30% of the above-mentioned, nominal monthly salary).

5) CVs of candidates are to be submitted electronically to the Greek Embassy gremb.teb@mfa.gr, please mention [Fieldworker] by **June 11th, 2017**. For those selected, a face to face interview will be required.
