Subject: Invitation to submit a tender for the purchase of a new car for the Permanent Mission of Greece to the OSCE

The Permanent Mission of Greece to the OSCE, in accordance with the Greek Laws Nr. 4412/2016, 4781/2021, 4782/2021 and Circular No. 66820/10.12.2021(DG ST-B, MFA), is going to purchase a new vehicle, with the trade-in of the existing vehicle, Audi A6, Typ 4G Limousine (purchased December 2017, current mileage: appr. 30.000 km), for a budgeted cost, not exceeding fortytwo thousand euros (€ 42.000,00)

In order to make this purchase, the Permanent Mission invites the above interested parties, to submit an offer, that will meet the following specifications:

A) Tender Submission Requirements

In order for your offer to be taken into account, it must include:

- The price of the new vehicle before trade-in (excluding VAT, due to exemption)
- The exchange value offered for the existing vehicle through the trade-in process. The Austrian NOVA tax will be covered by the byer
- The final value of the new vehicle after deducting the aforementioned exchange value, the cost of transport-delivery, and any other expenses/costs
- Detailed description/technical specifications of the new vehicle

B) Technical specifications

The new vehicle must meet the following criteria:

- Type: SUV, 5 seats
- New (not used)
- Gasoline engine with Plug-in Hybrid technology
- Model year: 2024, 2025 or 2026
- Automatic transmission
- Engine displacement: 1.900 - 2.000 cc
- 4 cylinders
- Winter tyres- all-season tyres
- Dark color
- Delivery within 2026

C) Evaluation Criteria

The supplier will be selected based on the most economically advantageous offer, taking into account the total cost of the new vehicle (including the trade-in and other costs) and full compliance with the above requirements.

D) Submission Details

The offer should be sent in electronic format (PDF format), to the address grdel.oase@mfa.gr, until Monday, 13.7.2026, 12:00 (CET).

Offers from interested companies that were not invited to submit one, will not be considered.

A contract will be signed between the selected supplier and the Permanent Mission.

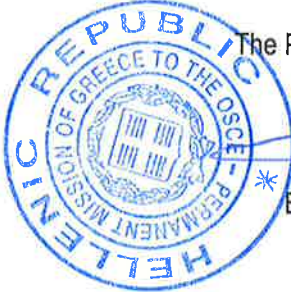
To complete the procedure, a representative of the Mission may visit your premises, with the existing vehicle, to discuss relevant technical/procedural issues.

The Permanent Mission of Greece to the OSCE reserves the right to request further information to evaluate the offers, which must be provided within a reasonable time. We also reserve the right to cancel/repeat the offer submission procedure, with or without modification of the terms. Participants cannot claim compensation in this case.

Before signing the contract, the company must provide an extract from the Business Register, a certificate of representation of the company by the person signing the contract, and the IBAN of the bank account to which the invoice amount will be transferred.
