Supporting documents for a visa application

1. One recent photo attached on the application.
2. Passport expiring at least 3 months after the scheduled return date (+copy) as well as previous passports (if any).
3. For Non-Thai Passport Holders: Please submit the following documents:
 - Work Permit in Thailand with a minimum validity of 2 years.
 - Residence Permit in Thailand.
 - Re-entry Visa to Thailand.Birth certificate in English (for children) and Applicants Traveling with a Spouse: Please provide a marriage certificate in English.
4. Letter of employment (original) or evidence of business ownership, such as Business Registration Certificate, Certificate of Student Status (for student)
5. Travel health insurance with minimum coverage the equivalent of 30,000 Euro(+copy)
6. Round-trip flight booking
7. Confirmed hotel reservation If residing in a Greek residence, you must submit the invitation letter, along with a copy of the inviting person's passport or ID card, and their income tax documents.
8. Bank passbooks or bank statements for **past 6 months** issued by the bank.
9. Tourist visa holders must be able to prove possession of the equivalent of 50 Euros per day for their stay within the Schengen area.
10. For meetings, business visits, or personal visits, an invitation letter stating the name and exact travel dates from the organization or company,
11. For minors under the age of 18, a letter of consent for travel is required.
12. For Thai seamen and individuals traveling to Greece for work or study, a Police Clearance Certificate and a Medical Examination Certificate are required, along with a work contract or a letter of acceptance (for study).
13. For wives of Greek citizens, a Family Status Certificate issued by the local authority in Greece is required.
14. Any other documents supporting **the purpose** and **circumstances** of the **trip**.

Remarks

*** Holders of official or diplomatic passports of the Kingdom of Thailand must submit an official letter from the Ministry of Foreign Affairs along with documents numbered 1, 2, 4, 6, and 7.**

*** Documents No. 3 and 4 in Thai must be translated into English and certified by the Consular Department of the Ministry of Foreign Affairs.**

*** The visa processing time takes approximately 7–14 working days, depending on the number of applicants during that period and the completeness of the applicant's documents.**

***Walk-in applications are not accepted under any circumstances.**
